### FILING YOUR LEGISLATION

- Each piece of Original Legislation (OL) must be numbered to be placed in the proper committee
- > Each OL will be assigned a four digit number. The numbering system is as follows:
  - The first number is a "1" for the Senate or "2" for the House of Representatives
  - The second number reflects the committee number
  - The third and fourth digit reflect the order your legislation was filed for the specific committee (01-99)
- ≻ Example: OL1234
  - This OL is in the Senate, Committee 2, and was the 34th bill filed in Committee 2
- The numbering process is done by the Attorney General's Office. To make sure that your OL is properly numbered and placed in committee, please follow the set OL deadline

### FIRST PAGE

- $\succ$  Start by setting the line spacing to 1.15
- $\succ$  Set the font for the first three lines to Courier New font size 16
  - Go down one line, then type in all capital letters and in bold for the first three lines "103ND GENERAL ASSEMBLY", "STATE OF ILLINOIS", "2023 AND 2024", centering all text
  - For the fourth line, set the font to 14 and type "OL". The rest of the number will be added for you later
- Add a line space, then switch to size 12 font and type "Introduced by (your position-Senator or Representative- then your name)
- Next line in Calibri (Body) font, size 14 font, in capital letters type "SYNOPSIS AS INTRODUCED"
- > Next line, size 11 font, cite the Illinois Statute you are drawing from (if applicable)
- Next line, finally type out your synopsis
  - The synopsis for your bill is a summary of what your bill does. In a paragraph or less, describe the impact of your bill

### FIRST PAGE (CONTINUED)

- Finally, go to the footer. Center the footer, and in Calibri (Body) size 14 font type
  - "A BILL FOR" in all capital letters, adding two spaces between the words
    - Make sure that when the footer is open, under "Design" hit "Different First Page:
- ≻ Overall...
  - **DO NOT PANIC.** If the first page seems too confusing, download the template and fill in your information as needed
  - $\circ\,$  If you have any questions, please reach out to the Attorney General for help

#### BODY OF THE OL

Look to the First Page Document for the exact wording and style for the body of an OL

- $\succ$  Tips for the rest of your OL:
  - Font size 12, font Courier New, spacing 1.5
  - Tab in to start a new paragraph
  - Only capitalize "AN ACT" and only bold "Be it an act..."
  - For the Header & Footer, make sure that "Different First Page" is clicked
  - Insert page numbers, deleting the number on the first page
  - Delete the "A BILL FOR" on subsequent pages as needed, it should only be on the first page
  - Add line numbers with the numbers restarting on each page. Highlight the first page, then click "Suppress for Current Paragraph" to remove the line numbers from the first page
- There are examples for all of these in the First Page Document. All questions can be sent to the Attorney General

### COMMON LANGUAGE/CONTENT TIPS

- $\succ$  Shall = Have to
- $\succ$  May = Can
- ➤ If the bill comes into effect immediately after becoming law, the effective date is "Effective immediately"
- Only write what you want the bill to do. Legislative intent, facts, and other talking points will be used to defend the legislation, but may not be put in the bill
- $\succ$  For example:
  - The bill language: "The state of Illinois shall give every employee the second Tuesday of the month off with pay. Effective January 23, 2055."
  - Talking points: Tuesday is a terrible day, employees need a consistently paid holiday, employers need time to prepare, etc.
- To add new language to a statute, <u>underline it</u>. To delete language from a statute, strike through it

• If you are creating a completely new act then nothing needs to be underlined
